- The Foundation and its donors distributed \$97 million in grants, a record amount.
- We received \$120 million in total donations and 58 new funds were established.
- The Foundation's total assets exceed \$1.2 billion (unaudited).

In 2017, we awarded nearly \$5.4 million in Foundation grants, including:

- **Cutting Edge Grants** totaling \$2 million to eight new and innovative programs in Jewish LA.
- **Next Stage Grants**—a new category—totaling over \$1 million to four organizations to support capacity building and customized, professional coaching.
- **Israel Grants** totaling \$1.65 million to eight programs that promote economic development and foster Jewish identity in Israel.
- **General Community Grants** totaling \$300,000 to seven local organizations that address human trafficking.
- **Capital Grants** totaling \$420,000 to three local organizations to support building projects that predominantly serve members of the elderly LA Jewish community.


